Egg Harbor Township Parks and Recreation Department proudly offers the Rhythm in the Park Summer Concert Series each year. Our concerts feature great entertainment and are held at the beautiful Robert J. Lincoln amphitheater at Canale Park. This letter is an invitation for all licensed EHT restaurants and food trucks to partner with us and make our events even more enjoyable by offering food, soft drinks, and treats for sale to our guests.

### Additional Details

- We will host up to two food vendors per night. If more than two establishments choose the same night, we will hold a lottery to draw slots. Additionally, the Township will ensure that “competing food options” do not share the same night.
- Food vendors should plan to serve food from approximately 6:00 – 9:30 p.m.
- We plan to cordon off a prominent area near the amphitheater for our food vendors to set up.
- If you are interested, please use the form on the last page to submit as your application.
- Food vendors will be required to submit the appropriate application with the Atlantic County Division of Public Health and comply with all regulations of the permitting process.
- The fee to be a food vendor is \$100 per night. Fee will be payable upon request after the due date and the Township has reviewed all applications.
- Please mail your application back to us by May 31, 2019.
