Your camp director, Glenn Carbonara, ended his professional career with the Philadelphia Kixx in 2003 having finished 15 years as a Pro. Glenn has played in 10 championship series and has come out on the winning end six times. Glenn was named to the All-Star team in 1995, 1998, 1999, 2000, 2001 and 2002. Glenn was named First Team All-NPSL and was Defender of the Year runner-up in 2001. Glenn has been a member of the U.S. Nation Futsol Team since 1996. Glenn was a four year starter at Rutgers University, and a Parade High School All American. Glen holds High School State Record for most goals in one season with 67. Glenn was named SOCCER PLAYER OF THE DECADE FOR THE 1980's by the Atlantic City Press and was inducted into the SOUTH JERSEY HALL OF FAME IN 1995.
