1. **SP 03-18** **Minor Site Plan**
Seaview Harbor Marina **9501/1 & 9601/1**
Zone: CRW, 4.789 acre site, Applicant 303 Longport Boulevard
Proposing to construct a “carport type” solar panel array above the existing parking lot for the marina/restaurant/clubhouse/office. A total of 1,656 solar panels are proposed. CAFRA

2. **V 04-17/SP 02-18** **“d” and “c” Varaince relief**
Grockenberger/Salani **Minor Site Plan**
Zone: R-3, 1.83 ±acres, sewer/water **6505/1 & 2**
Applicant is requesting use variance to allow for the Ocean Heights Ave. and Garden State Parkway
Operation of a contractor’s office and contractor’s workshop, in addition to the residential use, in the R-3
Zoning District where the commercial uses are not permitted and to allow for multiple uses on the lot.
Applicant is requesting bulk variances for the area and setback of the proposed freestanding sign and
minor site plan approval. CAFRA

The Commission requested the landscaping plan be changed from Bradford Pear to Redbud, Dogwood or Crepe Myrtle be planted.
