FOOD TRUCK APPLICATION INSTRUCTIONS

PLEASE READ CAREFULLY: The licensing period is from January 1 to December 31. Renewal applications must be completed in full detail and submitted no later than December 1st of the preceding year.

As per Article III in Chapter 129 of the Township Code entitled “Food Truck Vendor”, the following items must be completed, returned and approved prior to obtaining a license:

- APPLICATION:** Completed and filed by a corporate officer, business owner or partner of the corporation.
 - Corporations must submit a copy of Certificate of Incorporation
 - Partnerships must submit a copy of Operating Agreement
 - LLCs must submit a copy of Certificate of Formation

- BOARD OF HEALTH APPROVAL:** Copy of satisfactory Sanitary Inspection Report issued by the Atlantic County Division of Public Health. If you do not have a copy, please contact the Atlantic County Board of Health at 609-645-5971 to obtain a copy prior to submitting this application.

- VEHICLE CREDENTIALS:** Copy of the following documents for the food truck being used:
 - Valid Vehicle Registration
 - Valid Driver’s License for owner
 - Proof of an insurance policy issued by an insurance company licensed to do business in the State of New Jersey protecting the registrant and the Township from all claims or damages to property and bodily injury, including death, which may arise from operations under or in connection with the food truck vendor. Such insurance shall name as an additional insured the Township and shall provide that the policy shall not terminate or be cancelled prior to the expiration date without thirty (30) days' advance written notice to the Township. The amounts of the insurance to be maintained are: personal injury, one hundred thousand dollars (\$100,000.) per person, three hundred thousand dollars (\$300,000.) per occurrence; property damage, fifty thousand dollars (\$50,000.); and proof of general liability insurance providing a minimum of one million dollars (\$1,000,000.00.) coverage.

- APPLICATION FEE:** A \$20 nonrefundable application fee must be submitted at the time of application. Once application has been approved, the annual food truck license fee is \$100.

- BACKGROUND CHECK REQUIREMENT:** Background check instructions will be provided to you after you submit the application and all of the required documents above.
