

# Egg Harbor Township

## Ordinance No. 28

2019

### An ordinance to amend the Code of the Township of Egg Harbor, Chapter 165, entitled “Parks and Recreation Areas”

**BE IT ORDAINED**, by the Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey as follows:

**SECTION 1:** Chapter 165-6 entitled “Permits” is hereby amended by deleting in its entirety Section 165-6B (4), (5), (6), and (7) and replacing them as follows:

**§165-6B (4) Category IV Permit/Use:** Egg Harbor non-profit organizations/Egg Harbor Township church groups/Egg Harbor Township Boy and Girl Scout groups. Non-profit organizations, entities, individuals, or groups for the purpose of providing recreational services primarily to Egg Harbor Township residents must show proof of non-profit status and be able to demonstrate that their use of facilities benefits and/or serves Egg Harbor Township residents. Team rosters and/or intended participants must be seventy-five percent (75%) Egg Harbor Township residents or higher. If at any time the organization or team rosters falls below seventy-five percent (75%), the organization must immediately inform the Department of Parks and Recreation. This may result in the organization or team being reclassified into Category V.

**§165-6B (5) Category V Permit/Use:** Non-Egg Harbor Township non-profit organizations. Non-profit organization, entities, individuals or groups for the purpose of providing recreational services must show proof of non-profit status. Team rosters or intended participants with less than seventy-five percent (75%) Egg Harbor Township residents.

**§165-6B (6) Category VI Permit/Use:** Commercial organizations, entities, individuals or groups for the purpose of providing recreational services that are operated as a for-profit commercial enterprise.

**SECTION 2:** Chapter 165-7 entitled “Permit Fees” is hereby amended by deleting it in its entirety Section 165-7 B and C and replacing them as follows:

- B. Category IV
  - (1) Field use: \$25 per hour/three-hour block minimum
  - (2) Field use with lights: \$60 per hour/three hour block minimum
- C. Category V
  - (1) Field use: \$30 per hour/three hour block minimum
  - (2) Field use with lights: \$60 per hour/three hour block minimum
- D. Category VI
  - (1) Field Use: \$100 per hour/three hour block minimum
  - (2) Field use with lights: \$150 per hour/three hour block minimum
- E. Robert J. Lincoln Amphitheater: Categories I, II and III are permitted to use at no charge. Categories IV, V, VI will be charged in accordance to the fees set forth above in Sections 165-7 B, C, and D.

**SECTION 3:** All ordinances and parts of Ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

**SECTION 4:** Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.

**SECTION 5.** This Ordinance shall become effective immediately upon final adoption and publication according to law.
