

# Egg Harbor Township

## Ordinance No. 13

2021

### An ordinance to amend the Code of the Township of Egg Harbor, Chapter 165, entitled "Parks and Recreation Areas" specifically 165-6A entitled "Permits.", as amended

**BE IT ORDAINED**, by the Township Committee of the Township of Egg Harbor, County of Atlantic and State of New Jersey as follows:

**SECTION 1:** Chapter 165 of the Code of the Township of Egg Harbor, Section 165-6A entitled "Permits" is hereby amended by deleting in its entirety and replacing as follows:

#### **§165-6. Permits.**

A. Unless otherwise provided herein, no organizations, entities and for-profit individuals may use or conduct activities or special events in Township park(s) and recreation area(s) without a permit issued by the Parks and Recreation Department (the Department). An individual's use of a professional trainer without a permit is limited to one hour, when necessary in order to accommodate the public's use of the facility. Upon written application, each permit will be reviewed, categorized, and issued by the applicant's use, activity or event proposed, prioritizing each in the order set forth in Section B., with Category I having highest priority. The Department will make every reasonable effort to treat all organizations, teams, and individuals using Township facilities in a fair and equitable manner. All parties must comply with federal and state anti-discrimination laws.

Permits must be available for review at time of use upon request. Permits are nontransferable and for the exclusive use of the applicant who must be present during the use, activity or special event authorized. All permittees must adhere to their approved use at the locations, dates, and times authorized.

**SECTION 2:** All ordinances and parts of Ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistency, hereby repealed.

**SECTION 3:** Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.

**SECTION 5.** This Ordinance shall become effective immediately upon final adoption and publication according to law.
