Ordinance No. 4

2021

An ordinance fixing the salaries of certain officials and employees (Policemen's Benevolent Association) of the Township of Egg Harbor for the year 2021

WHEREAS, pursuant to N.J.S.A. 40A:9-165, the setting of such salaries shall be by promulgation of Township Ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Egg Harbor, in the County of Atlantic, New Jersey as follows:

SECTION 1. Salaries. That the salaries and compensation of certain officials and employees of Egg Harbor Township hereinafter named shall, commencing January 1, 2021, be and the same are hereby fixed and determined to be base salaries as follows and shall be payable in bi-weekly payments:

Section 5. This Ordinance shall take effect on January 1, 2021.
