Coaches and volunteers must meet the requirements of the Criminal Background Check process and our related Township Ordinance in order to be approved to coach in Egg Harbor Township, additional requirements and regulations to coach in EHT apply.

Ordinance 46 of 2007 was amended to include a clause requiring volunteer coaches to submit to a background check every five years.
